NOW, THEREFORE, it is hereby resolved as follows:

- 1. The above recitations are true and correct and are hereby incorporated into this Resolution.
- 2. The Board hereby resolves to consistently and uniformly enforce the covenants and restrictions found in the Declaration, Articles, Bylaws, Rules and State Laws; and together referred to as "governing documents") promulgated in connection therewith. Any violations of the Association's governing documents reported on or after the date of this Resolution shall be dealt with in a timely and even-handed manner in conjunction with the existing Declaration, Articles, Bylaws, Rules and State Laws; and

The Association, through its Board of Directors (as may be delegated to management), retains any and all rights to enforce the policies and use restrictions it may have pursuant to the Declaration of Condominium and/or other governing documents of the Association, including but not limited to filing liens, levying fines (if applicable) against the offending owner(s) as a result of the violations and/or seeking relief through an action at law or in equity. The Association will seek reimbursement for all attorney fees or costs associated with such actions as authorized by the aforesaid Declaration, Articles, Bylaws, Rules and State Laws. Unit Owners are responsible to ensure that all guests, tenants, and other occupants of their Unit remain in compliance with the covenants and restrictions contained in the aforesaid Declaration, Articles, Bylaws, Rules and State Laws.
